

These General Terms and Conditions shall apply to members of the Supply Chain Network, established in Noorderstraat 193, 9611 AE Sappemeer (the Netherlands).

General information / Definitions

- 1.The Supply Chain Network is part of the private limited company Visie Partners BV, established in Noorderstraat 193, 9611 AE Sappemeer (the Netherlands).
- 2. The purpose of the network is to create and maintain a community of students or former students of Visie Partners BV and members of the APICS /ASCM
- 3. The purpose of the community is to increase and share the knowledge and understanding of the management of logistic and administrative processes. To this end, the network organizes and/or supports initiatives aimed at increasing and sharing knowledge. These may include events such as company visits, network meetings and theme days, publications and research.
- 4. Members of the SCN shall be natural persons who have become a member in accordance with the terms and conditions of the SCN.
- 5. The financial year of the SCN shall be from January 1 up to and including December 31 of the same year.

Membership conditions

6. At the time of their application for membership of the SCN, the member shall comply with the following conditions:

They shall be a student or former student of Visie Partners, or a member of the APICS/ASCM.

7. Upon registration as a member of the SCN, the member shall agree to receiving the newsletters of the SCN.

Member registration

8. The board of the SCN shall keep a register containing the names, addresses and e-mail data of all members.

- 9. Each member shall be expected to update their details in their account.
- 9.1. Any and all consequences of any failure to communicate changes to the details shall be for the member's risk and expense.
- 10. The board of the foundation shall keep a register containing the first name, surname, address and contacting details of the members.
- 11. Members can earn so-called 'maintenance points' for the continuation of an APICS certificate. For this purpose, we shall keep track of the activities conducted by the participants as well as of the points earned thereby.

Subscription

- 12. A subscription year shall be from January 1 up to and including December 31.
- 12.1 In the event of paid membership, the board shall be entitled to adjust the subscription fee annually.
- 13. The member may cancel their membership with immediate effect in the event of a change of the subscription fee.

Upon registration in the course of the year, a proportionate part of the subscription fee shall be charged.

14. The invoice for the subscription fee shall be sent to you by e-mail no later than December 31 and must be paid before February 15. If you fail to pay, you will receive an e-mail reminder on February 1. If payment has not been made by February 16, your membership shall be terminated.

Participation in an event

- 15. Where possible, participation to an event is free of charge. Sometimes, however, a fee will apply, which must be paid upon enrollment via the website. The fees shall be published on the website.
- 16. The SCN shall notify its members in writing if an event is organized and enrollment is open.
- 17. The board shall retain the authority to set a maximum number of participants to a certain event.



- 18. Participation to an event shall be final when the fee has been paid.
- 19. Events shall be canceled in writing, no later than one working week before the date on which the event takes place.
- 20. If an event is canceled too late, any fee already paid shall not be reimbursed. There will also be an additional fee of €25, excluding VAT.
- 21. The board shall retain the authority to cancel an event in case of insufficient participation. The participants shall be notified hereof in writing no later than one week prior to the event, and any fees already paid shall be reimbursed within 10 working days.

Organizing an event

22. An initiative to organize an event shall be submitted via e-mail to the board of the SCN for approval.

Publication of articles

23. Any initiative to publish an article as well as the article concerned shall be submitted in writing to the board of the SCN for approval. The fees shall be assessed on the basis of the guidelines for the author.

Starting a discussion

24. The board shall retain the authority to terminate and remove a discussion in the event that inappropriate language was used and/or the purpose of the SCN and the community is jeopardized.

Termination of membership

- 25. The membership shall end:
- by the natural person's / member's death;
- by termination as described in Article 25 to 28 inclusive;
- by removal. This can only be pronounced if the member acts contrary to the conditions, regulations or standards and values of the SCN, or damages the SNC in an unreasonable manner.
- 26. A member who has terminated their membership shall remain obliged to meet the financial obligations ensuing from their membership.

- 27. The SCN can terminate a membership with immediate effect in case of failure to pay the subscription fee.
- 28. Termination on behalf of the foundation shall be performed by the board.

Liability

29. The SCN shall only be liable if damage was caused through willful conduct or gross negligence by the SCN or by its executive subordinates. Liability shall be limited to no more than the amount invoiced for the product or service concerned.

Disputes and applicable law

- 30. Membership shall be governed by the laws of the Netherlands.
- 31. Any disputes, both in fact and in law, shall be settled by the competent court of the jurisdiction in which the place of business of Supply Chain Network is located, unless the subdistrict court is competent.

General Data Protection Regulation (GDPR)

32. All data provided shall be processed internally and shall be used for a responsible member registration, a responsible business operation and the sending of information with regard to the activities of the foundation. The Supply Chain Network foundation shall not sell any personal data to third parties.

Additional provisions

- 33. The SCN shall have the power to make interim changes to these General Terms and Conditions and/or to impose additional conditions at all times.
- 34. In all situations where these General Terms and Conditions do not provide a solution, the board shall decide.
